**SUB: SAVE WEST BENGAL FROM DICTATORSHIP OF HON'BLE CHIEF MINISTER,  
SMT.MAMATA BANERJEE BY DECLARING PRESIDENT'S RULE**

Sir,

**“PREAMBLE OF THE CONSTITUTION OF INDIA”:**

**“WE THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC and to secure to all its citizens: JUSTICE, social, economic and political; LIBERTY of thought, expression, belief, faith and worship; EQUALITY of status and of opportunity; and to promote among them all FRATERNITY assuring the dignity of the individual and the unity and integrity of the Nation”.**

I am enclosing herewith 8 pages letter addressed to Hon'ble Chief Minister of West Bengal for Attn. Smt. Mamata Banerjee and also one copy of SMS dated 17.04.2019 sent through Mobile No. 09830233444 of Mr. Chandra Sekhar Dey, All India Secretary of Human Rights Council of India, Govt Registered NGO at A/106, Street N0.3, Dashrath Puri, New Delhi-110045 for protection of Human Rights, Certificate issued by National Human Rights Commission of India dated 30.01.2018, copy attached. I would like to analyse various activities mentioned in the 8 pages letter and SMS to Human Rights Council of India which will require for investigating and filling a petition to Chief Justice of Supreme Court for declaring 'President Rule' for this State establishing Democracy against Dictatorship as per British Regime.

Before wearing the crown as Chief Minister for the State of West Bengal we must disclose about her struggles viz: slogan, procession, 26 days hanger strike and when earlier Government declared 144 for stopping all procession She directed all cadres to break the 144 and the earlier Governments' Forces killed 27 cadres and after becoming state Queen every year she is celebrating martyrdom gathering at Dharamtala Maidan, Kolkata. Now she is establishing '**Maa, Mati, Manush Society for 40% Burgeon people** encircled with her

Party cadres, councillors, ministers and becoming Billionaire by sucking Blood of 60% **Categories of people**. After receipt of "**Biswa Kanya**" titled **Shield** she considered herself as another successor of Queen Victoria and she is empowered not to follow the "**Liberty of thought, expression, belief, faith and worship mentioned in the PREAMBLE OF THE CONSTITUTION OF INDIA mentioned above.**"

First Being a Queen She has issued Circular to all Publishers that all publication of new Books should be sent to **Sahitya Academy Centre** for editing and should take clearance from the Queen. Accordingly **Author's Book-"Evolution of Human Beings and Society"** has become victim and **Sahitya Academy Centre** giving clearance and advising Publishers collect 100% payment and advising them not to give proof reading to Author after changing publication page as per Author's instructions. Author has lost few lakhs rupees and when Author has filed a suit and awarded a judgment Orders and after Execution for Arrest Warrant all Police Stations given instructions not to arrest the Publisher. She has captured Film Industry and not allowing any film to display outside Kolkata without her permission. Film Director, Goutam Ghosh put up an Application to Chief justice of Supreme Court and Chief Justice passed an Order for Chief Minister of West Bengal to pay compensation for an amount of Rs. 21,00, 000/- to Film Director, Goutam Ghosh.

**1.EQUALITY of status and of opportunity; as mentioned in the above "PREAMBLE OF THE CONSTITUTION OF INDIA"**

- a) Present Queen given power to all cadres to collect chanda in cash from all shop keepers, hawkers etc. once or twice in a month and deposit to any bank opening SB A/c titled as Agent's commission for various individual agent's name operating signatory will be one to be controlled by group leader for making payment to the Road cleaner and other service providers 50% of total collection for salary, PF and ESIC amounting total Rs.6000/- to Rs.8000/- balance 50 % will be distributed among the cadres as commission. These people cannot make any complain/ grievances for demanding more money to maintain the full requirements of all family members and they must be signing blank receipts for accounting, filling the amount as per minimum wages Act. Few Crores Cash money making white money.
- b) Councillors and Boroughs' Chairman will collect from all Big Business Establishments including all Private Big Hospitals for maintaining party's advertisements/publicity and their commission.

c) Commissioner of Kolkata, all Ministers will collect commission from all Industrialists and Business Tycoons to build up their Assets and Properties like Millionaire and Billionaire.

d) Queen's Muscle Power keeping intact she has given power to Clubs, captured all Unions giving donations. Celebrities and Dignitaries' are tortured showing her power of **Biswa Kanya** titled **Shield** arranged from British Regime.

e) Queen's inhuman torture towards **60% BPL Categories of people** giving details as under:

1) First Queen has stopped issuing BPL Certificate through Councilor and she doesn't want to keep any document for hiding public knowledge of mal-nutrition death.

2) Health Care: Out of 6.97 Crores 4.18 Crores-**60% are BPL Categories people** and we have only 3 or 4 Government Hospitals in Kolkata where people are rushing from all districts of entire state for curing numerous diseases for free treatment. 67% discount on prescribed costliest medicine definitely arranged with medicines manufacturers by increasing MRP Price @ 68%. This agreed % Author has checked with local Medicines Shop while trying to exchange with other medicines but the Shop Keeper refused to give the exchange saying your medicine is 68% increased price as per sample shown of one script arranged by Didi with the Medicine Manufacturers and they cannot exchange, plus additional 100% for subsidising all Doctor's Salary and all pathological and Radio graphical expenses. At the time of UPA Government period Prime Minister Medicine's price increased 400% as per Pharmaceutical and Drug Association's demand. Patients get tired standing on the queue for hours together and pathological tests time get closed. Patients are coming by trains/buses from long distance completing half day or full day journey. There was a Report that after curing any critical diseases likes Dengue, critical surgery etc. Dr. will prepare total detailed expenses and will take patients signature for accounting purpose. But Queen is writing on Hospital Wall that "**SU-SWASTHA TE SABAR AAGE BANGLA**". Photograph attached. Publics quarries when such a huge cash collection from publics, Business Tycoons, Industrialists etc. What about GST collection, Income Tax, Corporation Tax etc. Why not utilising for Aushman medical Jojana, Rojgar Jojana, Nibas Jojana etc.? Queen has arranged 'Z' security for related MP Mr. Abhisek Banerjee's Office cum Residence in Harish Mukherjee Street including CCTV arrangement, anybody find doubtful, Security Guard will question and allow them to cross the Road. In Times India news paper that 'Z' Security Scenery has been photographed and inscribe in the news paper. And Queen threatened that she will

move to Delhi for slogan; procession etc. if CBI and Central Enforcement /Investigation groups enter in this 'Z' security area.

- 2.) Human Rights Council of India (Central & State):- Author has become Member since 01.01.2018 by paying Rs.2000/-. And also was attended in Seminar arranged in one Police Station near Kharagpur Rly. Station, West Madinipur where Mr Jiban Das (Central) and Mrs Sharmistha Dhar (West Bengal State) were present and I have given a copy of my Book. On humanitarian ground Author has given few Economical cases including settled outstanding of Rs.17,48, 000/- from M/s Kolkata Weir Industries Ltd. Mr. Chandra Sekhar Dey, All India Secretary of Human Rights Council who arranged with Mr. Abhisek Banerjee Economical cases including settled that Author has to give rupees three lakhs donation, one lakh advance to Mr. C. S. Dey of Human Rights Council of India and Position of Chairman in the Governing Body list of **NGO-"Purbachal Senior Citizens'Society"** and also obtained **Certificate for the exemption u/s 80G (5)(vi)** whose Founder Secretary is **Author, Sukhamay Bhattacharya. Mr. Sukhamay Bhattacharya, BPL Certificate Holder** could arranged Rs.68, 000/- taking loan of **Rs. 50000/-** from **Kabliwala** keeping **Guarantor, one Builder** and balance from **Mr. Tapan Halder, one NGO Cheater. Govt. registered NGO-"Human Rights Council of India"** created by present **CM/Queen** where Humanity is available on payment of Fees and donation in advance but not free. No mercy for BPL Certificate Holder. Mr. Chandra Sekhar Dey, All India Secretary of **Human Rights Council of India** told Sukhamay Bhattacharya, Founder Member, Secretary of **NGO-"Purbachal Senior Citizens'Society"** that he got eleven Projects across the country and only in Bengal he got Four Projects for establishing Co-operative Banks, Titled must be given **'Biswa Kanya Co-operative Bank'** learned from Chandra Sechar Dey of HRCI when Secretary of **NGO** asked for refund of his Rs.68,000/- he asked me to come next day after giving call. Since next day, 9<sup>th</sup> May'19 onward he never respond and even Mr Jiban Das another member also not responding.
3. Out of 6.97 Crores population 46% Muslim Population. One of my friends sent one Script in my Face Book copied from one News Paper-'JOGASANKHA' about the **Queen's** statement in one Sanghati Dibas Auditorium on 7<sup>th</sup> December, 2017 that She does not believe 'Hindu Dharma', Xerox Copy of the Script attached herewith. But her inhuman torture towards **60% BPL Categories of people** where maximum are from 46% Muslim religious people if any day She visits all Hospitals.
